Information for Bequests in Wills & Trusts

YOU CAN BEQUEATH

- The remainder or residue of your estate (*what is left over after your other bequests*)
- Your entire estate
- A percentage of your estate
- A specific dollar amount or specific assets
- A contingent bequest that passes to the Florida Lighthouse Association, Inc. in the event your primary beneficiary predeceases you.

MODIFY YOUR EXISTING ESTATE PLAN

WITH AN AMENDMENT TO YOUR TRUST OR A CODICILS TO A WILL

If you do not want to rewrite your estate planning documents, you can still remember Florida Lighthouse Association, Inc. by using a codicil to your will or an amendment to your trust.

FLA recognizes donors who include a charitable gift in their estate plan

PHAROS SOCIETY COMMEMORATIVE ROLL OF HONOR ~ FLA recognizes donors who make cumulative gifts of \$25,000 or more, IN PERPETUITY

- \$25,000 can rescue and completely restore an out building on an historic lighthouse grounds
- \$50,000 can completely restore the inside iron work of an historic lantern room or can restore a 150 year old Fresnel lens

LIGHT KEEPERS LEGACY SOCIETY ~ recognizes donors who include a gift in their estate plan

- **An estate gift of \$100,000** can completely restore all the historic ironwork in a brick lighthouse tower or fund a years worth of archeological or historic research by a graduate student team.
- **A gift of \$1,000,000** will restore a lighthouse because that is what it costs to completely restore one of the towers -- and that restoration has to be done every ten years
